20:16 ConEd Chapter

The issue of whether to recognize ConEd as a "Corporate Chapter" was debated heavily.

Arguments for:

- ConEd employs many Maritime grads, and hires many Maritime students
- There are a large number of Maritime Grads currently at ConEd providing an opportunity to encourage support for FSMAA
- ConEd is a big supporter of Maritime college

Arguments against

• Establishes a precedent that once established will have to be followed

- Potential (either real or perceived) of a conflict of interest
- By-laws not drafted with Corporate chapter in mind
- Conflict with not-for-profit corporate regulation not verified
- Adds another complication with MOU discussion with NYS AG

The issue was eventually put to a motion to recognize ConEd as a chapter with 3 provisos'

- 1. The ConEd chapter would have no voting rights
- 2. The ConEd chapter would be a "Beta" release i.e. a pilot
- 3. All 31 members of the ConEd chapters would need to be verified as active members

Motion: Earl Baum "I motion that to accept ConEd chapter [as non-voting as a pilot] pending verification of the active status of the ConEd chapter members
