### 19:57 MOU Status – Dan Gillette

The latest MOU approved by FSMAA board was sent to College and forwarded to NYS Attorney General (AG) and Comptroller. State replied within in 2 weeks with exceptions to Waiver 5 and 6.

<u>Waiver 5</u> – Required compliance with NYS Not-For-Profit Revitalization act. FSMAA will seem an expectation as FSMAA is incorporated with State of Delaware not NY. FSMAA can comply with NYS revitalization term IF THEY DO NOT CONFLICT with Delaware Corp. Laws.

<u>Waiver 6</u> – Requires audit to be complete within 60 days. FSMAA will seek an expectation as FSMAA is constrained by resources. Will request an extension to 5 months.

Dan has authorized external legal consultants to talk to state directly to try to resolve. Dan to also set up call with An Gerson to find out difference between NYS and Delaware regulations.
