1819 - Admirals Report - Michael Alfultis, President of Maritime College

The Admiral shared with the Board the College's COVID Metrics:

- Low confirmed case numbers in Jan., higher numbers during the first 2 weeks of February.
- Overall, Maritime College has a 1.5% positivity rate
- 73% regiment, 23% civilian
- Freshman & Senior classes represent largest % of positive cases
- Primary Concerns:
 - o Activity in Dorms
 - Off Campus Activity
- High degree of focus on mental health issues for entire campus
- MCAA to assist in sponsoring an event to improve overall student body moral

1833 - Treasurers Report - Kevin Comerford

Proposed budget for January has been sent to the Admiral and the College.

Synced up Paycheck Protection Program (PPP) which was approved in January and added \$16k to income (loan forgiven), putting the association up \$10,000 for the month. Additionally, the MCAA picked up \$3,500 in dues and expenses were \$10,000.

Overall the funds started the 2021 year at a total of \$11.7 million and now stand currently at \$11.6 million.

Application filled out and approved for second PPP for \$16,053 and that money will deposited into Chase account this week.

Summer Sea Term Scholarships, \$454,000 available for SST and the Class of '65 is sponsoring \$32,000 out of their fund, \$4,000 per student (4 Deck & 4 Engine Cadets). Puts the SST total to now \$486,000 out of a goal of \$500,000.

General Updates:

- Working with Assistant Treasurer Sam Reilly on new and improve performance summaries from Fiduciary Trust reports.
- Class of '73 Looking to establish a scholarship fund and a meeting will be set up next week to further discuss.
- Finalizing annual report for next week.
- New Executive Director position will begin on March 1, 2021.
