April 2022 Meeting Minutes

1803: Call to Order

- Approval of March Meeting Minutes

1805: Chapters Update

- Art Sulzer Philadelphia
 - Next event is June 11 when the Empire State is in town. Secured the Seaport Museum 4th floor for a reception from 4-7.
 - Cadets will be able to attend the Museum for free.
 - Will be arranging tours to the shipyard to see the new Training Ship
- **Dennis Brennan** Southern California Chapter:
 - Question on the status for Chapters formalizing their status. Need to understand the status for members in the area to understand who can vote within the Chapter
 - Action Item- Art recommends having a separate Chapter President meeting to get the Chapter presidents onboard

1831: Executive Director's Report – Jeanne Murphy

- Student Intern has been hired for 10-12 hours per week. Graduating in May.
- Margaret is working in the Fort part time. Primarily entering checks into the database.
 - The full-time associate alumni association role has been posted on LinkedIn.

1835: Presidents Report- Kevin Danko

- Discussed the Regimental review report. The Admiral spoke with the 1/C regarding the report. There was going to be a redacted report released, but then the decision was made to release the full report. G-Captain got their hands on the report and posted it to their news site.
 - The Admiral requested the audit and plans to address the issues found.
- Been working on funding for SST funding to mitigate the increasing cost. There is a
 possibility to get some funding fuel through a discretionary fund, should know in about 12 weeks.
- New York State has a cadet appointment program which is a scholarship that covers cadet tuition. \$1.2 million dollars was funded for this program pending the Government sign-off.
- Starting next month in May, the plan is to resume in-person Board meetings with the Microsoft Teams options.

1852: Treasurer's Report – Sam Reilly

- Budget
 - o March 2022
 - Net income for the YTD (\$39,202.52)
- Budget highlights a. Dues \$1,260 received in Mar 2022
 - \$9,100 received YTD.
 - Under 2022 budgeted number \$70,000
 - Underway Fund \$3,016.48 (YTD)
 - June Golf
 - Annual Alumni Dinner +\$3,620 for March, \$4,200 YTD (\$30,220 brought in in December)
 - No January dinner in 2021 rescheduled for April 29th
- Funds January 1, 2022 \$12,926,718.19
 - o March 31, 2022 12,064,158.56 -7.40% (955K)
 - SST 22' \$439,921.69 available cadet scholarship (4% of 3 year average account balance)
- Sam mentioned that he met with FTI earlier in the month to review the fund and their lookout for the year.

1908: Committees

- Scholarship Committee; John Valvo; reviewed the 2022 SST Scholarships. There were a few issues that came up but have been resolved. Total contribution of \$504k to be given to 98 students for SST (less 1 from last meeting because the cadet is not going on SST).
- Events/Honors Committee: Leo Imperial & Jeanne Murphy;
 - Alumni awards dinner on 4/29. Currently at 201 seats sold. Looking for approximately 40 more people to attend, asking the board for help. Next year we recommend having the dinner in January again.
 - Golf outing June 13th, registration has gone live.
 - Spring Networking event is not going to take place this year because of the conflicting events.
- Magazine Committee; Ted Mason; Current magazine is in good shape; articles have sticked to the theme of inclusiveness.
 - Delivery date has been moved out to 6/30/2022. This was a request on behalf of the Admiral. Concerned about this because we won't be able to advertise for the Golf Outing which is the biggest fundraising event of the year.
 - Need to align the magazine release dates to best promote scheduled events.
- Audit Committee; John Valvo; have the new auditor (Buchbinders) who are in process of obtaining the working documents from the previous audit company. Working through getting the requests through.

- **Membership:** Seth Lucas; Asking for list of alumni. Seth posted a poll on the Fort Schuyler Shipmate Facebook page, received a lot of responses. Only about 30% of over 4,000 members were current members of the Alumni Association, with 45% previous members and the remainder were never members.
 - Seth reached out to some of the former members who were concerned that their dues don't go to the cadets. The money is used for operational expenses to enable fundraising.
- PR Committee: Richard McClain; Some activity on the social media for events, spotlights etc. Have been reaching out to some alumni from a provided roster to engage alumni for a spotlight.
 - Discussed working with Jeanne for updates to the website
