December 2022 Meeting Minutes

1806: Call to Order

- Approval of the November Meeting Minutes with two minor revisions (Blackbaud name correction and interim* daily operation actions)
 - Motion put forth Motion carried, all in favor, motion carries

1811: Chapters Update

Art Sulzer (Philadelphia) – Had a golf and crab event in September, about 16 attendees.
The next event is the 13th annual all Academy holiday party this coming Tuesday.
Expecting a good number of attendees, working on getting more to attend the event.
Also hoping to get an event in the Spring at the Navy yard to get a tour of the ship.

1813: Treasurer's Report – Sam Reilly

- Budget (information through October 31, 2022)
 - o \$20,994.74 YTD
 - Net income YTD (\$85,262.94)
- Budget highlights
 - O Dues \$1,480 for October
 - \$15,600 received YTD
 - Under 2022 budgeted number \$70,000
 - Underway Fund \$5,509.89 (YTD)
 - June Golf \$25,136.99 (waiting on another \$25k)*
 - Annual Alumni Dinner \$30,600.87* (pending 25k payment from McAllister)
 - Ancient Mariner \$(2,403.80)
 - o Total Revenue from Events: \$62,745.56 (net)
- Funds January 1, 2022 \$12,926,718.19
 - November 30, 2022 \$10,646,864.50 down -15.46% (approx. -1.995mil) asset appreciation/ -17.53% on ending balance (includes net flows & income earned)
- The main items to be reconciled are the 25k from McAllister (Jeanne said they are sending the check), confirming the Ancient Mariner number (believe we should be net even), there is still work that needs to be done with Kamal to go through payments/coding to get up-to date.
- Saira was added as an approved person to access the Chase account.

1845: Report from the College - Doug Hasbrouck

- Finals are this week and the campus is starting to empty out.
- Doug and his team have been working with Maggie on upcoming items/transition
- The Admiral is discussing announcing the 150th anniversary of the legislature creating the school on paper in April of 2023 running it through January of 2025 when the St. Mary's would've sailed off.
 - The Admiral wants to work with the Alumni Association on this and potentially having it culminate at the Alumni dinner in January of 2025.

- Looking at doing the christening of the new ship after SST on the same day of the Admirals dinner. They are planning on testing the main engines this coming week.
- Magazine they are still hoping that it will hit the original mail date. Encouraging us to do social media marketing through LinkedIn or Instagram.

1852: Committees

 Honorees, and she is working on gathering their information. Leo is working on
 the medals for the dinner. Ted will work with Electric Boat to ensure they have

- Nominations Committee; Mike Trotta; Reviewed the ballot sent out ahead of the meeting. One person who has not yet graduate (undergrad) has not yet graduated (predicted to graduate in Jan 2023)
 - 1920 Motion to accept the ballot, minus the individual (Katherine Mattikow) who has not yet graduated as of this date. Motion carried, all in favor, motion carries
 - The ballot will be posted into survey monkey and then distributed for voting. Voting will open on December 18th and close on Sunday the 8th, then the results will be gathered ahead of the first meeting in January, 2023.

- As part of the Strategic plan, Vic and Leo discussed the potential change in the bylaws related to membership. Proposing that anyone who is a graduate is an alumni of the college.
