# **February 2022 Meeting Minutes**

#### 1807: Call to Order

- Approval of December Meeting Minutes
  - Motion put forth Motion carried, all in favor.
    - Two abstains from Annmarie and Leo who didn't have a chance to review, motion still carries.

# 1816: Report from the College - Dr. Michael Alfultis

- Review of the college, regiment etc. expecting results
  - Campus climate task force, provided 16 recommendations, 10 have been implemented
- Summer Sea Term Schedule
  - Philadelphia planned for June 10-14.
  - o Portugal June 26 30
  - Belfast July 14-18
    - They are planning alumni events in Philadelphia and hoping to have one in Belfast Ireland for the last leg. Working with the Titanic Museum in Ireland.
- Highlight where alumni can help with SST; cost for SST will be between \$12,500 (in-State) to \$15,000 (out-of-state).
  - Hoping to get the state to subsidize the SST. Asking for connections on state members to subsidize who may be working on the State budget
  - Looking for fuel donations to keep fuel costs down
  - Looking for Mates/Engineering/faculty for SST
- Fall event for the TSES VI getting towed away in fall, 2022 for an alumni event before the ship gets towed away
- Working on a homeport event in April 2023 for the arrival of the TSES VII

## 1825: Executive Director's Report – Jeanne Murphy

- Leo is stepping up as the chairman of the Events Committee
- SST Appeal is underway, need to raise approximately \$25,000 to donate the goal of 511K
- Jeanne has been meeting with the Strategic Planning Committee, they plan to share the findings at the June meeting.

- Connecticut Maritime Conference (CMA) on March 29-31; working to tie something in
- Working with the SGA for the Spring festival (early April)

# 1847: Treasurer's Report – Sam Reilly

- Budget as of January 31, 2022
  - Net income YTD: -(\$10,263.93)
  - Loss is primarily due to not having a dinner. Income is lumpy and contingent on the events.
  - Overall fund is down due to recent market volitation.
- Budget highlights
  - o Dues \$5,160.00
    - Under 2021 budgeted number \$70,000
    - Below 2020 \$57,830
    - Below 2019 \$81,750
    - Below 2018 \$70,740
  - Underway fund \$54,034
    - Sole donation of \$25,000 was received on Dec 31, 2021
  - Small Business Loans Received \$32,284 in 2021
- **1851**; **Correction** from the 2021 financials, a loss of -(\$262.00) was reported, however there was as an adjustment of a –(\$10,000.00) because this money was incorrectly coded as Underway Fund.
- Need to receive a vote for the 2022 budget. Then the budget needs to be presented to the college. Bring this to the March meeting for a vote.

#### 1901: Committees - Kevin Danko

- Membership Committee: Seth working to get the membership meeting going next month. Kevin spoke with him offline, Seth not able to attend this meeting.
- 1933; Audit Committee; John Valvo; Officially have broken ties with the former audit and tax preparer. We have the new companies engaged heading in the right direction. Need to ensure we have corrective actions in place from the 2020 audit, formalize implementation dates.
- **Events Committee:** Leo has taken over as the Chair for this committee. Nothing to report currently.

- 1912; Honors Committee; Ted & Leo: The honorees are aware of the new
  date. Need to consider who the honorees are for the next dinner in January, the
  board needs to approve the honorees for the selection. They would like to see
  diversity in selection of honorees. Please send any suggestions to the honors

- 1901; Public Relations Committee; Rick McClain; Looking to increase post
  frequency (where are they now and alumni spotlight posts), please send any post
  recommendations. Jeanne will be hiring a current student to assist with social
  media. Should push out to the Career Fair to the other alumni to encourage
  alumni participation.
- **1910**; **Magazine Committee**; **Ted Davis**; Publication is underway. The College has set the theme for successful graduates with a focus on female graduates.
  - The magazine schedule is not normally favorable for advertising of the major events.
- 1932; All Hands Committee; John Valvo; Annmarie looking into the training program for everyone to go through.

#### 1935: Unfinished Business - Kevin Danko

- No progress has been made on merchandising since last meeting. Kevin had a conversation with the admiral about college official specific branding centered around old & new TSES, but no outcome yet.
  - Still have some left over gear, discussing the next way to sell this.
