- John Valvo did the check presentation for the 2022 Summer Sea Term scholarship, good participation from alumni and cadets.

1826: Treasurer's Report – Kevin Danko (on behalf of Sam Reilly)

- Budget (information as of May,31, 2022)
 - o \$11,200 YTD
 - Net income YTD (\$13,239.35)
- Budget highlights
 - Dues \$820 for May
 - \$11,220 received YTD.
 - Under 2022 budgeted number \$70,000
 - Underway Fund \$4,107 (YTD)
 - June Golf \$45,340
 - Annual Alumni Dinner \$23,087 (+\$25,000 from McAllister pending check)
 - Total Revenue from Events: \$68,438
- Funds January 1, 2022 \$12,926,718.19
 - April 30, 2022 down 14.6% (approx. 1.9mil)
