## • Nominating – Mike Trotta:

- Held Virtual Nominations Meeting on Tuesday, 16 November.
  - Putting together ballot with old and new nominees
  - Final slate will be sent to the Board for review and approval

## • Events – Mike Trotta/Jeanne Murphy:

- Homecoming Positive feedback received thus far
  - Annual Meeting had low attendance due to location on campus to comply with COVID protocols
  - "Swag Sale" went well Spent \$4,200, brought in \$3,700
  - Keep focus on membership for future events
- Highest raising Ancient Mariner event Raised \$11,000 this year, up from \$7,000-\$8,000 in prior years

## Finance/Treasurer's Report – Kevin Comerford:

- Budget:
  - October 31, 2021
    - Net income (\$59,716)
      - > \$1,120 increase in dues in the month of September
      - \$215 increase in the Underway Fund in the month of September
- o Funds:
  - January 1, 2021 \$11,746,195
  - October 1, 2021 12,658,798
  - Withdrew approx. \$403,000 for scholarships this year. Funds up just over \$500,000 on the year.

- The second Paycheck Protection Program loan was forgiven on October 26th. We moved \$16,053 from the 'temporary liability' line on the budget to income.
  - The \$16,053 is shown as income on this month's budget (and we still lost \$15,856 this month).
- I updated the end of the year budget estimate. I anticipate we will lose approximately \$20,000 this year. This number assumes the following:
  - We bring in \$35,000 in Dues in December
    - ➤ We bring in \$12,000 in Jan Dinner payments
    - > We have a nice end of the year Development take
    - ➤ We have \$7,500 in Ancient Mariner pledges still outstanding
    - ➤ We need to give Old Westbury \$10,000 for a deposit
    - ➤ Dues mailer cost \$5,000
- Finance Committee had our annual review with FTI on October 7th. Good review and gave us some talking points for the Annual Meeting at the Fort on Homecoming. A lot of market instability right now. They feel we are positioned well to ride through it.
- Audit John Valvo:
  - Auditors Completed audit with a better than prior year results
    - Working on outstanding items, year after year
  - Going into an engagement with Buchbinder for Fiscal Year's '21,'22,'23
    - Had a kickoff meeting with the team with audit committee and admin staff
  - Current audit by auditors has been completed
    - Received final draft of auditors management letter late last week
    - Will turn over to Board to have visibility of findings
