A year in review

The Maritime College Alumni Association (MCAA) marked 2024 as a year of growth, engagement, and lasting impact. Under the leadership of President Stephen J. Carbery '80, the Association deepened connections with alumni and strengthened support for Maritime College students and programs.

The year featured a full calendar of events bringing the Maritime community together. Highlights included the **Distinguished Alumni Honors Dinner** at Tribeca 360°, where Joseph P. Starck '90 and Captain Robert Cook '80 were recognized for their achievements; the **35th Annual Golf Classic** at Plainfield Country Club; the Ancient Mariner Golf Outing, Homecoming Weekend, and several networking gatherings in New York City. New initiatives such as the **Privateer Recruitment Officer Program (PROP)** engaged alumni in outreach and mentorship, extending Maritime's reach to future cadets.

Financially, the MCAA remained strong, with its investment portfolio surpassing **\$13.5 million**, a **12.77% increase** from 2023. Over **\$532,000** in scholarships supported **107 cadets**, including two full-ride Summer Sea Term awards honoring Professor Sembler and Chief Pflieger. New scholarships—such as the **Detective Jonathan Diller '14** and **Patrick Baeszler '14** awards—reflected the continued generosity of alumni.

Looking ahead, the MCAA aims to expand chapters, enhance communications, and grow engagement opportunities. Through steadfast membership, mentorship, and momentum, the Association continues to advance its mission and support the next generation of mariners.

This continues to be the premier maritime industry golf event in the New York metro area.

On July 1st, we proudly welcomed to campus Rear Admiral John Okon '91 USMS (USN Retired) as our 12th president of SUNY Maritime College. Rear Admiral Okon is joined by his wife Valerie Gessner Okon class of 1992.

On Monday September 16th, we held our first Privateer Recruitment Officer Program or PROP Training program. 12 alumni volunteers came back to campus to immerse themselves in life at SUNY Maritime College today to prepare them to speak to today's prospective college applicants.

We kicked off Homecoming Weekend with our Annual Ancient Mariner Golf Outing on October 18th, 2024, at the Pelham Bay & Split Rock Golf Courses. One hundred fourteen golfers enjoyed a brisk fall day followed by cocktails, dinner, and awards.

Saturday, October 19, marked Homecoming Day as the Class of 1974, celebrating their 50th graduation anniversary, marched smartly into St. Mary's Pentagon followed by the MUG class led by their IDOs. Reunions for the classes of 1969, 1964 and 1959 also participated in the Pass & Review ceremony. We also honored the latest Heritage Hall inductees included Dr. Richard Burke '72 and Kevin Tokarski '84. A packed-house Association Annual Meeting was conducted at 1230 hours which was followed by tours, tailgating and football. The day concluded with a reception at Paddy's On The Bay at 1600 hours generously sponsored by the Gerson family. It is always wonderful being back on campus at Throggs Neck on the Peninsula of Opportunity!

November 26th saw our 2024 Networking & Nominations meeting at Reichenbach Hall on 37th Street in Manhattan. We received nominations for officers and our board of directors for our 2024-2025 elections. We thank all who have served in the past and those that remained involved in important committee work.

Supplementing our in-person events, we expanded our online outreach efforts and grew our social media presence in 2024, keeping alumni informed and engaged with the Association and the College.

Chapters

Thanks to the work of Seth Lucas '01 our Chapters & Membership Committee Chair, we continue to strengthen our organization through expanding our chapters across the country and internationally.

Scholarships

Thanks to your generosity, we raised \$214,462.04 through our 2024 SST Appeal to support cadets preparing for the Summer Sea Term. We continued to manage our endowed and restricted scholarship funds prudently, resulting in over \$215,000 available from 4% draws against long-term endowed funds valued at over \$13.5 million. These funds help ensure our support remains steady and impactful.

Financial Summary

Our investment portfolio grew steadily in 2024, closing the year at \$13,535,506.44 — a 12.77% increase from the start of the year, and a 25.79% increase over two years. Our portfolio is allocated across 73.49% equities, 19.51% fixed income, and 7.0% short-term holdings, benefiting from strong performance in both the S&P 500 and Russell 1000 Growth indices.

Looking Ahead

In 2025, we aim to expand our offerings and engagement opportunities for alumni. Our goals include:

- Working with the College Admissions department to assist them with potential student applicant outreach to increase enrollment through our PROP program.
- Strengthening our speakers' program to connect more students with experienced alumni.
- Strengthening our chapters to extend outreach communication with alumni.
- Developing new in-person events to accommodate diverse schedules and interests nationwide.
- Enhancing our communication platforms to keep alumni informed and involved.
- Upgrading our website and database to allow graduates to update their information and allow alumni searches for friends and colleagues.

Your continued support is crucial in helping us achieve these goals.

Scholarship Giving



Greetings fellow Alumni!

This Scholarship Giving Report summarizes the MCAA's financial Scholarship Awards in fiscal year 2024.

In 2024, the MCAA distributed a record amount of **\$532,990** to students to help defray the cost of the 2024 Summer Sea Term, awarding to a total of **107 deserving cadets**. Two cadets received the full cost of the 2024 Summer Sea Term Tuition (\$12,995 in-state). These two Full Tuition Scholarships were presented in the names of Chief Edward Pflieger and Captain William Sembler '52. First-Class cadets received **\$6,000** scholarships towards their cruise tuition, equating to covering almost 50% of their tuition! SST Scholarship Awards were opened up to 3rd Class Cadets this year for the first time. We were able to award \$2,000 Scholarships to 28 Third Class Cadets. **How great is that!** This scholarship money is the result of the financial growth of the many endowment funds under our care and supplemented by the **generosity** of our Alumni Association membership. Refer to the Treasurers Report for details on the various Fund Performance.

Included in the SST awards:

- Class of '65's Scholarships for 2nd Class Cadets (2 Deck and 2 Engine), each in the amount of \$5,000.

A few new Scholarships were added this year:

- The Detective Jonathan Diller Class of 2014 Scholarship award was presented to a 1st Class Deck Cadet in the amount of \$6,000.
- The Patrick Baeszler Class of 2014 Scholarship awarded \$4,000 each to 3 Staten Island Cadets.
- The Class of '83, having-co-joining with Class of '65, awarded their Inaugural Class of '83 Scholarship in the amount of \$5,000 to a deserving 3rd Class Deck Cadet.

In addition to the Summer Sea Term Scholarships listed above, several scholarships were issued throughout the year:

- The Class of October '46 Tomb Speaker Series (Support for the College) - \$5,000.00.
- The Charles Balancia Scholarship given to an incoming 4th Class Cadet - \$1,500.00.
- The Class of 1967 Academic Scholarship - two (2) Scholarship - \$4,500.00 each as well as a \$1,000 SallyPort Award to a Graduating Cadet.

Since 2004 the MCAA has donated **over \$5.4 million** dollars to the cadets and the school in the form of scholarships!

Full Ride Scholarships

Established in 1982, two full-ride Summer Sea Term scholarships have been awarded to First Class cadets. In 2014, alumnus Dan Gillette '97 proposed renaming the scholarships in honor of Professor Sembler and Chief Pflöging—two remarkable educators whose dedication and mentorship left a lasting mark on generations of Maritime students. Each scholarship fully covers the cost of the recipient's First Class Cruise, regardless of tuition status, ensuring that financial barriers never stand in the way of this defining experience.

A Legacy That Sails On

The Class of 1965 and Their Enduring Commitment to Maritime Cadets

Nearly six decades after tossing their caps in the air, the Class of 1965 continues to leave an unmistakable wake at SUNY Maritime College—one defined by camaraderie, service, and an unwavering belief in supporting future mariners.

What began as a 50th class reunion gift has evolved into one of the Alumni Association’s most vibrant

and hands-on scholarship initiatives. Spearheaded by Captain James Callahan ‘65, the class’s scholarship committee meets quarterly, keeps classmates connected through newsletters, and continues to grow a scholarship fund dedicated to helping today’s cadets navigate the unique financial challenges of a Maritime education.

“We were horrified to learn how much students now pay for their Summer Sea Term,” Captain Callahan recalled. “When we sailed, it might have cost us a few hundred dollars. Today, cadets face costs of \$10,000 to \$15,000—and they can’t work over the summer to offset it. We wanted to help fix that.”

Anchored in Shared Experience

The Class of ‘65 built its fund around the heart of what makes Maritime College unique: the Regiment of Cadets, the Merchant Marine License Program, and the life-changing experience of the Summer Sea Term.

The Class of 1965 and Their Enduring Commitment to Maritime Cadets

Their scholarships specifically support second-class cadets, those midway through their journey at sea. “We felt that by the second-class cruise, these students had proven their commitment,” explained Callahan. “They’ve made it through the early challenges and are serious about earning their license.”

Each year, the committee awards two deck and two engine scholarships, currently valued around \$6,000–\$7,000 each, with a goal of one day providing full-cruise coverage. Recipients are chosen jointly with the MCAA Scholarship Committee, based on merit and dedication to the program.

“When classmates see the caliber of these young men and women, it inspires them,” said Callahan. “It’s not just about writing a check—it’s about being part of something that changes lives.”

Steady Course and Future Crew

As the Class of ‘65 embarked on their 60th reunion, its members have also been preparing for the future. Recognizing that time and tide wait for no one, they recently partnered with the Class of 1983 to ensure the mission continues long after their own watch ends.

The merged Class of ‘65/’83 Scholarship Committee, now fifteen members strong, is already sharing duties—from managing communications to mentoring successors. Each scholarship is awarded in honor of a deceased ‘65 classmate, preserving the stories and spirit of those who served before.

“Our goal is to make sure the fund keeps growing, even when we’re gone,” said Callahan. “We’ve encouraged classmates to include the scholarship in their legacy giving. It’s our way of keeping the class alive in perpetuity.”

Service Beyond the Sea

Captain Callahan’s own story mirrors the selfless ethos of his classmates. After graduating in Marine Engineering, he served 27 years as a commissioned officer with the NOAA Corps, commanding three vessels and later teaching government contract law for nearly two decades. His reflections remind us that what lasts from a maritime career isn’t just the work—it’s the people.

“People ask me what my best job was,” he said. “Without question—it was being Commanding Officer of a ship. The work was fascinating, but it was the people who made it unforgettable. It truly was like a family.”

Today, that same spirit of family defines the Class of ‘65’s relationship with Maritime College. Their steadfast commitment, personal involvement, and mentorship of a new generation stand as a testament to what can happen when shipmates keep steering together long after graduation.



Treasurer's Report

The MCAA remains financially strong and steadfast in its commitment to our cadets, students, alumni, and the mission of Maritime College.

Greetings, Maritime College Alumni - Community,

My name is Sam Reilly, Class of 1995, and I have the honor of serving as Treasurer of the Maritime College Alumni Association (MCAA). I am pleased to present the Annual Treasurer's Report for Fiscal Year 2024.

This report summarizes the MCAA's financial position for the year. I'm happy to share that, overall, we achieved positive investment results. The stock market performed well, and our managed funds reflected that growth.

That said, we experienced a net operating loss of \$38,454 in 2024. This was largely due to lower-than-expected revenue from our Annual Spring Golf Classic compared to prior years, along with higher operating costs in areas such as payroll and event expenses. Despite this, the MCAA remains in a strong financial position. The Board is reviewing strategies to increase revenue and better manage expenses in 2025.

Event & Revenue Highlights

- Annual Awards Dinner (January): Net profit of \$108,221
- Spring Golf Classic: Net income of \$56,425
- Spring and Fall Networking Events: Net income of \$10,682
- Total Gross Revenue (2024): \$252,290

- Net Income (2024): Loss of \$38,454 (vs. projected budget of \$290,744.62)
- Operating Expenses: Approximately \$19,885 per month (includes salaries, IT, and phone)

Scholarship Funds – Fiduciary Trust International

- Opening Balance (Jan 1, 2024): \$12,048,054
- Closing Balance (Dec 31, 2024): \$13,535,506
- Increase: \$1,487,452 (+12.77%)

Scholarships & Support Provided

In 2024, the MCAA distributed \$551,455 to students to help offset the cost of the Summer Sea Term.

Additional awards included:

- Class of October '46 Tomb Speaker Series – \$5,000
- Charles Balancia Scholarship (incoming 4th Class Engineering Cadet) – \$1,000
- Class of '67 Sallyport Scholarship – Two awards of \$500 each
- Class of '67 Scholarship – Two cadets, \$2,250 each per semester, totaling \$9,000


